

Business Strategy by Mr Moiz Lakdawalla, Head API Marketplace, Signzy

To help the start-ups gain perspective on challenges they are currently facing and to restructure their business strategies if necessary. Start-ups gained perspective on the various challenges they are facing and several solutions to boost sales.

<u>Importance of Digital Marketing by Mr Yash Chandiramani, Founder and Chief</u> Strategist at Admatazz

To teach the importance of Digital Marketing in a real-life start-up scenario. Students and start-ups learnt several concepts about the use of keywords and google ads.

Financial Plan Tracking by Dr. Rakhi Sharma, Mentor In-Charge

To analyse the finances of the incubatees. The incubatees put their sales and operation costs into numbers and gained a statistical progress report.

Legal Session by Mr Pragyaan Pittie

To aid start-ups to cover themselves legally and assess the most logical channels of existence. Start-ups gained great perspective on legal setup and business strategies.

Legal Advice for a start-up by Mr Vishal Tiwari, Founder and Managing Partner at Veteran Global Lawyers and Associates

The session helped solve the start-up's queries regarding registration as a company and the various legal aspects to be kept in mind when starting a business.

Intellectual Property Rights in association with the Government of India, Ministry of Commerce and Industry, DPIIT, Office of the Controller General of Patents, Designs and Trademarks (under the National Intellectual Property Mission) by Dr. Latika Dawara (Assistant Controller of Patents and Designs, Patent Office, Mumbai)

The session helped the students and start-ups to gain insights on trademarks, patents, copyrights and how they can protect their start-ups. The speaker also explained the procedures and requirements for getting a patent.


