COMMERCE

- 1) A candidate eligible for admission to the Bachelor of Commerce Degree Course shall have passed XII std. Examination of the Maharashtra State Board of Secondary & Higher Secondary Education or its equivalent and secured not less than 35% marks in aggregate at one & the same sitting.
- 2) Every Candidate admitted to the Degree Course in the Constituent/affiliated College/recognized institution, conducting the Course, shall have to register himself/ herself with the University.
- 3) In the F.Y. Degree course the following subject combinations are available. All students to take Accountancy as MAJOR & Commerce (Business Management) and Economics as MINOR subjects.

SECOND YEAR under NEP

Option of choosing Accountancy as Major/ Commerce (Business Management) as Minor.

OR

Accountancy as Minor/ Commerce (Business Management) as Major will be available to students based on availability of seats and merit.

THIRD YEAR under NEP

Major/Minor combination of subjects will be as opted for in SY.
NO INTERCHANGE of MAJOR/MINOR subjects at TY LEVEL .

THIRD YEAR under NON-NEP

Third Year NON-NEP B.Com. students will have to choose Accountancy or Business Management (Commerce) based on their choice in SY.

Interchange from Accountancy to Business Management or vice versa will be allowed based on availability of seats and merit.

Every Candidate admitted to the Degree Course in the Constituent/affiliated College/recognized institution, conducting the Course, shall have to register himself/herself with the University.

Cut-off percentage for In-house students opting for FY (SCIENCE) - MICROBIOLOGY as the MAJOR subject in the chosen combination = 60%

Cut-off percentage for In-house students opting for FY (SCIENCE) - LIFE SCIENCES as the MAJOR subject in the chosen combination = 60%

M.COM. – ADVANCED ACCOUNTANCY

The eligibility for admission to M. Com. Program is as per the criteria laid down by University of Mumbai & the Government of Maharashtra.

Admissions will be on the basis of merit (percentage of aggregate marks/grade secured at the qualifying examination). Reservation criteria shall be followed as prescribed by the Government at the time of admission.

The total number of seats under this Program is 60.

Admissions to PG Programs M.Com. – Advanced Accountancy **will be ON THE BASIS OF MERIT ONLY.**

M.Sc. – BIG DATA ANALYTICS

- For being eligible to apply for admission to the Program, the learner should have passed either B.Sc Data Analytics / B. Sc.IT. / B.Sc. C.S. / B.Sc. Mathematics / B.Sc. Statistics / BCA / B.Tech./B.E. degree examination of this University or an equivalent degree of any other University with a minimum of 46 credits or its equivalent (i.e. the minimum credits required for majoring in a subject, and excluding the credits for optional courses) in the subject which he wants to offer for the M.Sc. degree program by papers provided the above candidate undergoes the proposed Bridge Course of 1 credit each in Mathematics, Statistics and IT, each for a duration of 15 hours, satisfactorily.

OR

- Students who have graduated majoring in Economics, with Econometrics as one of the Courses or students who have graduated in BAF/BMS/BBA/BFM/BBI/BCom Program of this University or any other University equivalent thereto will also be eligible for admission, provided they had passed Standard XII Board Examination with either Mathematics or Statistics as one of the subjects and undergoes the proposed Bridge Course of 1 credit each in Mathematics, Statistics and IT, each for a duration of 15 hours, satisfactorily.

AND

- Provided further the candidates hold a Graduate/Post Graduate Degree with a minimum of 60% marks or CGPA 6.5 on a 10-point scale in the qualifying Degree of BSc/ BCA/ B.Tech./B.E./ BA/ BAF/ BMS/ BBA/ BFM/ BBI/ BCom or equivalent will be eligible for this program provided he/she has scored not less than 60% in aggregate at the other threshold Examinations of Standard X and Standard XII.

***Note:** Candidates from the SC / ST Category will be eligible for a relaxation of 5% in respect of the above requirement.

- Candidates, who are in the Final Year of their Degree Program, are also eligible to apply and will be given conditional admission in that they are to appear and pass in the final examination with a minimum of 46 credits or its equivalent (i.e. the minimum credits required for majoring in a subject, and excluding the credits for optional courses) in the subject and complete other academic requirements as specified above. For such cases, admission will be provisional subject to submission of final mark sheet.
- An Entrance Exam will be conducted for admission to the course.
- Maximum intake for the program per year is 30.

Admissions to M.Sc. Big Data Analytics **will be ON THE BASIS OF MERIT ONLY.**

Eligibility & Admission Criteria:

A learner for being eligible to apply for admission to the M.Sc. degree course by papers in Chemistry must have passed: -

The B.Sc. degree examination of this University or degree of any other University recognized as equivalent thereto with Minimum 46 credits or its equivalent (i.e, the minimum credits required for majoring in a subject, and excluding the credits for optional courses) of the subject which he wants to offer (Chemistry) for the M.Sc. degree course by papers.

Admissions will be based on merit (percentage of aggregate marks/grade secured in Sem 5 & 6 of B.Sc.).

Admissions to M.Sc. Chemistry **will be ON THE BASIS OF MERIT ONLY**

NO IN - HOUSE QUOTA FOR THE ABOVE MENTIONED PG PROGRAM

For MSc Chemistry, there are 10 Aided and 10 Self-financed seats available under 3 specialisations: Organic, Inorganic and Physical

B.Sc. - IT

A candidate for being eligible for admission to the degree Program of Bachelor of Science-Information Technology (BSc.IT), should have passed XII standard examination of the Maharashtra Board of Higher Secondary Education or its equivalent with Mathematics and Statistics as one of the subjects and should have secured not less than 45% marks in aggregate for open category and 40% marks in aggregate in case of Reserved category candidates.

OR

Candidates who have passed Diploma (Three years after S.S.C. – X Std.) in Information Technology/ Computer Technology/ Computer Engineering/Computer Science/ Electrical, Electronics or Video Engineering or Allied Branches/Mechanical and Allied Branches/ Civil are eligible for direct admission to the Second Year of the B.Sc. (I.T.) degree Program. However, the Diploma should be recognized by the Board of Technical Education or any other recognized Government Body. Minimum marks required: 45% aggregate for open category candidates and 40% aggregate for reserved category candidates.

OR

Candidates with post HSC-Diploma in Information Technology/Computer Technology/ Computer Engineering/ Computer Science/ Allied branches will be eligible for direct admission to the Second Year of B.Sc. (I.T.). However, the Diploma should be recognized by the Board of Technical Education or any other recognized Government Body Minimum Marks required: 45% aggregate for open category candidates and 40% aggregate for reserved category candidates.

Admissions will be ON THE BASIS OF MERIT ONLY.

PROGRAM WISE ELIGIBILITY CRITERIA

XII) examination conducted by the Maharashtra State Board of Secondary and Higher Secondary Education or its equivalent from any other Board. (Arts, Commerce or Science stream). **Students with gap are also eligible to apply in the Vocational Degree Program, but must have a valid Gap Affidavit and required proofs for the gap.**
