

5. As per Rule 236 (1) of GFR 2017, the accounts of all Grantee Institutions or Organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
6. The Institute will keep the whole of the grant in a Bank Account earning interest, and the interest so earned should be reported to DBT in the Utilization Certificate and Statement of Expenditure. The interest so earned should be refunded to the Consolidated Fund of India through Bharatkosh (NTRP) portal.
7. No International Travel will be undertaken from the sanctioned project grant unless specified otherwise.
8. The Institute/Agency will keep the whole of the grant in a Bank Account earning interest, and the interest so earned should be reported to DBT in the Utilization Certificate and Statement of Expenditure. The Interest so earned will be treated as created to the institute/Agency and shall be adjusted towards further instalment of the grant and or at the time of Final Settlement of Accounts.
9. Out of which the interest earned amount of Rs.126525/- +2976/- (Rs.2911/- I.E.+ Rs.65/-NR Balance) has been remitted by the college to the Consolidated Funds of India through Bharatkosh.
10. The Competent Authority has allowed a sum of Rs.-188266/- to be carried forward to the current financial year. NO UC is pending.
The other terms and conditions governing the financial sanction will remain unaltered.
11. The final utilization certificate is enclosed herewith.
12. This issues under the powers delegated to this Department as per IFD Order No.BT/04/2015 dt.15.04.2019 and with the concurrence of IFD, DBT, vide their SAN No.102/IFD/SAN/319/2022-2023 dated 15.07.2022.
